## Show Details:

All art and crafts must be original work. Artist/Artisan must be present in booth for the duration of the Festival, and must attend for the entire weekend. Exhibited work must be consistent with photos submitted to jury. All artwork must be of high quality and hand-crafted. We will not accept vendors who use manufactured goods or kits, and you will be required to leave without compensation or refund.

All booth spaces 10' x 10'. You must provide your own straight legged booth.

Only one (1) artist is permitted per booth space, unless accepted as more than one.

If you are selected, when it gets closer to the event dates, you will receive specific information regarding designated free parking, set-up times, booth location, special events, etc.

Free parking during Festival for all exhibitors behind the high school for one vehicle.

Free overnight parking for RV (no facilities).

Let us know about any special needs or awards or anything else you think we should know.

We plan to publish and link to your website address. If would prefer that we don't, please let us know. We respect your information privacy.

## Jury Process:

A jury of arts and crafts professionals will determine the exhibitors of the Festival.

All applicants must submit four (4) photographs or jpeg images by email of their work, and one (1) image of your booth all clearly labeled with your full name. NO SLIDES, PLEASE.

Photographs will NOT be returned.

## Application Prices and Due Dates:

A 10' x 10' booth space for the entire weekend is \$290.00; premium spots are \$340.00. There is also \$15.00 non-refundable jury fee which must be paid y check and which will be cashed immediately.

**(Premium Spots are Near Bridge St Entrance at Front of Festival, OR are Corner Spaces and are a limited quantity, first come basis Specify, Corner or Entrance.)  
(Please ask for your preference on the application.)**

The completed Exhibitor Application must be submitted with two separate checks, each made out to the New Hope Chamber of Commerce, or with a check for the jury fee and complete credit card information. All accepted exhibitor checks will be cashed by June 1, 2012. All others will be returned or wait-listed on request. Credit cards will be charged upon acceptance. There will be a \$30.00 fee for any checks that the bank returns to us.

Applications and checks must be received by May 31, 2012.

Applications postmarked by March 31, 2012 will receive a discounted rate of \$265, or \$315 for a premium booth. After May 31, there is a \$25.00 late fee.

## Cancellation Policy:

Cancellations prior to July 1, 2012 will receive a full refund.

Cancellations up to six (6) weeks prior to the festival will receive a refund of booth fee less \$125.00.

There will be no refunds for cancellations within six (6) weeks of the Festival.

## Special Considerations:

Please let us know if you have an oversized vehicle, have special needs parking or other needs. You must let us know how much unload time, set-up time you need, and your preferred arrival time. It is your responsibility to have an applicable Tax ID and to collect and pay taxes for your state.
