



## 2012 NEW HOPE OUTDOOR ARTS & CRAFTS FESTIVAL FOOD VENDOR INFORMATION

**September 29-30, 2012 Saturday 10AM - 6PM Sunday 10 AM - 6 PM**

The Festival will occur at the New Hope-Solebury High School this year with its ample parking and high visibility. A limited quantity of food vendors will be accepted and set up in a food court area. Selection is based on appropriateness of food type for this festival, in the order of applications received.

***Note that electricity is available for \$50 if needed, no generators are permitted, and that clean-up is mandatory.***

Please review and complete the attached application, and return it, along with your Space Rental Fee for each 10' x 10" space, Electricity Fee, if needed, and mandatory Refundable Security Deposit, to:

All completed applications must be received with payment by May 1, 2012.

**Compliance with the following Fire Code Standard is required:**

1. No open flames of any kind (from charcoal, propane, gas stoves, wood, etc.) are permitted in the tents. Cooking with open fire must be done behind the tents.
2. All food vendors who cook food must have an ABC type fire extinguisher.
3. All storage items must be kept behind or inside the tent. No storage of any kind is permitted on the sides of the tent.

**Compliance with the following Festival rules is also required:**

1. Tent and food service vehicles may be set up within the food court area for "in-vehicle" service and sales. We will need to know the size dimensions and vehicle set-up to place you accordingly. Please be considerate of other vendors and do not block traffic.
2. You must have a Vendor Parking Permit to park and you may park only in the area designated for vendor parking. Display your permit on the front dash or front window of your vehicle.
3. Set-up is between 6 – 9 AM each day. All vehicle traffic will cease at 9 AM.
4. Vendors are responsible for their own garbage clean up. Receptacles will be provided for your use. Do not dump grease or batter or any other food products, or any trash of any kind, onto the street, parking lot, grass, riverbank, or into the river. A \$150 security deposit is required, and will be used to pay for clean up if these rules are not followed. This deposit is fully refundable if your premises are left clean and in the same condition as before set-up.
5. Electricity is available with advance notice, for a charge of \$50 for the weekend.

**Permit from the Board of Health is required for participation in the Festival. Please remember to bring it with you.**
